- Station Number Chief Schmidt spoke with Chief Halverson of xxxx regarding the use of station number 50 that they are not currently using but are holding in reserve. Waiting for a response.
- RFA Update Letter to the City Discussion held regarding proposed staffing changes by the newly formed RFA that includes the City of Arlington. The paramedic change would adversely affect District #21 and other local agencies. It was the consensus of the Board to send a letter to the RFA on Friday, September 1, stating the District's and other agencies' concerns.
 - Chief Schmidt proposed the use of the Cushman Model to help with budgeting and staffing planning. The District would partner with North County Regional Fire Authority to purchase the program at a cost of \$1,250.00 for the District.
 - Commissioner Isler moved to partner with North County Regional Fire Authority for the purchase of the Cushman Staffing and Budgeting Module at a cost of \$1,250.00 to the District; Commissioner Safford seconded. Motion carried by unanimous vote.
- 2018 City Contract ALS & Fire Services District #21 has negotiated a contract with the City of Arlington to handle our own BLS transports starting in 2018. Cascade Hospital will be the main transport destination. District attorney is currently reviewing the contract before signing.
 - Question was asked about how well the Volunteer Firefighter response is on calls. Chief Schmidt stated that it is real good. Also, he just put two Volunteers into an EMT class.

Commissioner Reports:

- VFIS (8/22, 11/7) Commissioner Safford gave a report. Question asked if the District is monitoring total hours worked by employees who also work for other agencies. Chief Schmidt said that they are being monitored and explained the process.
- Financial Next month's workshop will be a budget meeting. Chief Schmidt will ask
 Tribal agencies for financial assistance for some projects/purchases. He proposed
 building two bedrooms for firefighters, and will use the Community Center for meetings
 and training. Is currently seeking bids for the bedrooms.
